## RULING U/S 25-A NO. 331

## Note:

i) The customs value determined under this Valuation Ruling shall be applicable customs value for assessment of the relevant goods until and unless revised or rescinded by the competent authority.

ii) Review application against this valuation ruling may be filed before the Director-General of Valuation under Section 25D of the Customs Act, 1969, within(30) thirty days from the date of determination of customs value under this ruling.

SUBJECT:

DETERMINATION OF CUSTOMS VALUE OF MINERAL GREASE (H.S.CO 2710.1992) UNDER SECTION 25A OF THE CUSTOMS ACT. 1960.

Valuation of Mineral Grease was determined under section 25A of the Customs Act, 1969, vide Valuation Ruling No Reg. I /26/ 2007-I, dated 31-12-2009. Since the said ruling was considerably old and needed up-dation, as per current international prices, the same was taken up for fresh determination

- 2. Meeting was held on 03.01,2011, which was attended by the representatives of importers and all stakeholders. The representative association of commercial importer contended that the price of Saudi Arabia, UAE, Hong Kong, & China origin Mineral Grease, determined earlier, were fixed on higher side, however, this plea was not acceptable as they could not substantiate their statement with any supporting document. The representative of one of the importer on the contrary stressed that their declared transaction value was even higher than the value determined vide earlier Valuation Ruling. Similarly, one local manufacturer also pointed out that the prices of Lube Base Oil has globally increased, which may be incorporated in the revised valuation.
- The data of imports of the instant goods of Saudi Arabia, UAE, Hong Kong, & China origin of the relevant period was analyzed within the meaning of section 25(5) & (6) of the Customs Act, 1969. The declared/assessed prices of imported goods namely Grease from Saudi Arabia, UAE, Hong Kong, & China origin was observed to be otherwise static but the L/C based transaction were found to be comparably higher in respect of certain items of the existing customs values. Market enquiry under the Deductive Method of Valuation under section 25(7) of the Customs Act, 1969, was also carried out for verification/determination of customs

value of Mineral Grease, which showed a price increase on an average basis @ 11.71%. As regards section 25 (8) of the Customs Act, 1969, since the details of conversion cost of goods produced in the country of export was not available, this provision was not found applicable. Based upon these findings, with particular emphasis upon the change in prices reflected in specific categories/grades, Customs values of mineral grease (HS Code. 2710.1992), are determined under section 25(9) of the Customs Act, 1969, as under:
