VALUATION RULING U/S 25-A NO. 368

Note:

- i) The customs value determined under this Valuation Ruling shall be applicable customs value for assessment of the relevant goods until and unless revised or rescinded by the competent authority.
- ii) Review application against this valuation ruling may be filed before the Director-General of Valuation, under Section 25D of the Customs Act, 1969, within thirty(30) days from the date of determination of customs value under this ruling.

SUBJECT: DETERMINATION OF CUSTOMS VALUE OF (EMPTY HARD GELATIN CAPSULES (H.S.CODE 9602.0010), UNDER SECTION 25A OF THE CUSTOMS ACT, 1969.




Values of Empty Hard Gelatin Capsules were determined vide Valuation Ruling No: 140, dated 31.12.208. Since the prices in the International Market have undergone changes, therefore these values were taken up for fresh determination.

2. Accordingly, meetings were held on 09.02.2011, 07.06.2011, 27.06.2011 and 05-07-2011, which were attended by the representatives of M/s Pakistan Chemists & Druggists Association, Karachi, M/s KAAF Impex, Karachi and M/s Khalid Ilyas. The participants agreed to determine the values, keeping in view the prevailing international price trend. The import data of the instant goods, from various sources, was analyzed within the meaning of section 25(1), (5) & (6) of the Customs Act, 1969. It was observed that the subject goods are being imported from Canada, France & China and are being cleared as per existing valuation ruling. To update the current prices, a local market inquiry was conducted by associating the above referred representatives.

3. In view of the findings of the market enquiry, the following customs values of Empty Hard Gelatin Capsules have been determined, in terms of deductive value method, as envisaged under section 25(7) of the Customs Act, 1969;
