DETERMINATION OF CUSTOMS VALUES OF VALVES UNDER SECTION 25-A OF THE CUSTOMS ACT, 1969

(VALUATION RULING NO.602 / 2013)



In exercise of the powers conferred under section 25-A of the Customs Act, 1969, the Customs values of Valves are determined as follows:-

- 1. Description of the valuation issue: It was brought to the notice of this Directorate General by clearance Collectorates that Valves were being imported at under invoiced values. an exercise was initiated to determine the Customs values of the subject goods under Section 25-A of the Customs Act, 1969.
- 2. Method adopted to determine customs values: Valuation methods given in Section 25 of the Customs Act 1969 were followed. Transaction value method provided in Sub-Section (1) of Section 25 ibid was found inapplicable because the requisite information was not available. Identical / similar goods value methods provided in Sub-Sections (5) & (6) of Section 25 ibid were applied read with Sub-Section (9) of Section 25 of the Customs Act 1969. Model Customs Collectorate of Appraisement (East), Karachi also forwarded proposed values of Valves which are in conformity with the prices worked out by this Directorate General.
- Stakeholders' participation in determination of Customs values: Meetings were fixed with stakeholders on 01-10-2013 and 04-10-2013.
- 4. Customs Values for Valves: Valves hereinafter specified, shall be assessed to duty / taxes on the Customs values mentioned against them in the Table below:

Review of the value determined vide this Valuation Ruling: A review petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.
- 8. The Collectors of Customs may kindly ensure that the values given in the Ruling applied.
