### DETERMINATION OF CUSTOMS VALUE OF ADAPTERS UNDER SECTION 25-A OF THE CUSTOMS ACT, 1969

#### (VALUATION RULING NO.606 / 2013)

No.Misc/07/2013-VII

Dated: November 06, 2013

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969, the Customs value of Adapters is determined as follows:-

- 1. Description of the valuation issue: A reference was received from erstwhile Model Custom Collectorate (PaCCS), Custom House, Karachi regarding under invoicing in import of Adapters. This prompted an exercise to determine the Customs values of the afore stated goods under Section 25-A of the Customs Act, 1969.
- 2. Method adopted to determine Customs values: Valuation methods given in Section 25 of the Customs Act, 1969 were followed. Transaction value method provided in Sub-Section (1) of Section 25 was found inapplicable because requisite information was not available. Identical / similar goods value methods provided in Sub-Sections (5) & (6) of Section 25 were also not found applicable due to unreliable and variable values. Consequently, findings of market enquiry as envisaged under Sub-Section (7) of Section 25 of the Customs Act, 1969 were adopted to determine the Custom value for Adapters.
- 3. Stakeholders' participation in determination of Customs values: Meetings were convened with stakeholders on 20-09-2013 and 23-10-2013. However, no one attended the meetings.
- Customs Values for Adapters: Adapters hereinafter specified, shall be assessed to duty / taxes on the Customs values mentioned against them in the table below: -

- 5. In cases where declared/ transaction values are higher than the Customs value determined in this Ruling, the assessing officers shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act 1969. In case of consignments imported by air, the assessing officer shall take into account the differential between air freight and sea freight while applying the Customs values determined in this Ruling.
- 6. Validity of this Valuation Ruling: The values determined vide this Ruling shall be the applicable Customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Sections (1) or (3) of Section 25 of the Customs Act, 1969.
- 7. Review of the value determined vide this Valuation Ruling: A review petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.
- 8. The Collectors of Customs may kindly ensure that the values given in the Ruling are applied without fail.
