DETERMINATION OF CUSTOMS VALUE OF MOTORCYCLE PARTS UNDER SECTION 25-A OF THE CUSTOMS ACT, 1969

(VALUATION RULING NO.664 / 2014)

No. Misc/31/2007-VIIIA

Dated: March 31st, 2014

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969 the Customs values of Motorcycle Parts are determined as follows:

- Description of the valuation issue: Customs values of Motorcycle Parts were determined vide earlier Valuation Ruling No.458/2012 dated 24-05-2012. Subsequently, Customs Appellate Tribunal Karachi set aside Valuation Ruling No.458/2012 vide Order dated 08-03-2013. Accordingly, an exercise to determine the Customs values of Motorcycle Parts afresh was initiated under Section 25-A of the Customs Act, 1969.
- 2. Method adopted to determine Customs values: Valuation methods given in Section 25 of the Customs Act, 1969 were followed. Transaction value method as provided in Sub-Section (1) of Section 25 was found inapplicable because requisite information was not available. Identical / Similar Goods Value methods provided in Sub-Sections (5) & (6) of Section 25 ibid could not be followed because of considerable variation in declared values among various import values of subject goods. Consequently, findings of market enquiry under Deductive Value Method in terms of Sub-Section (7) of Section 25 of the Customs Act, 1969 were adopted to determine the Customs values of Motorcycle Parts read with Fall Back Method under Section 25(9) ibid.

Stakeholders' participation in determination of values: Meetings were convened with the stakeholders on 17-03-2014 and 24-03-2014 attended by representatives of KCCI, All Pakistan Motorcycle Spare Parts Importers and Dealers Association (MSPIDA), Pakistan Automotive Manufacturers Association (PAMA), Association of Pakistan Motorcycle Assemblers (APMA) and Local Motorcycle Assemblers. The representative of PAMA stated that many motorcycle parts were being assessed at values below raw material cost and that determination of Customs value for commercial importers on the lower side was diverting the Chinese brand OEMs towards commercial imports. The representative of APMA pointed out towards the huge difference kept in previous Valuation Ruling between OEM and commercial imports and requested to determine single values for both OEM and Commercial importers. MSPIDA representatives were of the view that replacement / non genuine motorcycle parts

were of lower quality / price than OEM parts and therefore their Customs values may be determined separately in the light of market values. They further stated that the Customs values for commercial importers determined vide Valuation Ruling No.458/2012 may be reviewed.

4. Customs values for Motorcycle Parts: Motorcycle Parts of China origin hereinafter specified shall be assessed to duty / taxes on the customs values given against them in the Table below: -

5. In cases where declared/ transaction values are higher than the Customs values determined in this Ruling, the assessing officer shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officer shall take into account the

- differential between air freight and sea freight while applying the Customs values determined in this Ruling.
- 6. Validity of this Valuation Ruling: The value determined vide this Ruling shall be the applicable customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Section (1) or (3) of Section 25-A of the Customs Act, 1969.
- 7. Review of the value determined vide this Valuation Ruling: A review petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.
- 8. The Collectors of Customs may kindly ensure that the values given in the Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed with respect to PCT may kindly be brought to the notice of Directorate General immediately.
