**S.R.O.497(I)/2009.**- In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to exempt on import into Pakistan from Peoples Republic of China the goods specified in column (3) of the Table below, falling under the Heading and sub-Heading numbers of the First Schedule to the said Act as specified in column (2) of the said table, from the whole of customs duties in excess of the rates specified in column (4) of the Table;

Provided that the goods are manufactured or produced and imported in conformity with the provisions of the Ministry of Commerce Notification No. SRO 1286(I)/ 2005, dated the 24th December, 2005 read with the Import Policy Order, 2008.
