**NOTIFICATION  
(CUSTOMS)**

S.R.O. **811**(I)/2013–. In exercise of the powers conferred by sections 3DDD and 4 of the Customs Act, 1969 (IV of 1969), and in supersession of its Notification No.236–HQE/2000, dated the 25<sup>th</sup> September, 2000, the Federal Board of Revenue is pleased to notify the composition of the Directorate General of Input Output Coefficient Organization (IOCO), Pakistan Customs in Karachi for the purpose of exercising powers and duties conferred and imposed under the said Act, and appoint,—

- (a) the officers of Customs specified in column (2) of the Table below to be the Director General, Input Output Coefficient Organization (BS-21) and Directors, Input Output Coefficient Organization (BS-20), for the areas specified in corresponding column (3) thereof; and
- (b) as many Additional Directors, Deputy Directors, Assistant Directors, Appraisers and other officers and staff of Customs for the areas specified in column (3) thereof, as the Director General may require for the efficient working of the Directorate:—
