
**S.R.O.NO.38 (I)/2017**.- In exercise of the powers conferred by sub-section (5) of section 18 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to direct that the following further amendment shall be made in its Notification No. S.R.O.1178(I)/2015, dated the 30<sup>th</sup> November, 2015, namely:-

In the aforesaid Notification, after clause (b), the following new clause shall be inserted, namely :-

"(bb) imports of goods classifiable under PCT codes 52.01, 52.03, 5503.1100, 5503.1900, 5503.3000, 5503.4000, 5503.9000, 5504.1000, 5504.9000, 5506.1000, 5506.3000, 5506.9000 and 5507.0000;"


S.R.O.No. (I)/2017. In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to exempt the whole of customs duty leviable under the schedules to the said Act on import of goods specified in the table below, namely:-
