- Ail GDs shall be received at the Customer Service Centre through the receiving counter. However, the same shall be delivered on the next working day.
- No assessment shall be made on a GD manifested on Budget Day. Even Exbond GDs presented on 06th June 2005, shall not be processed on the Budget Day. No sale shall be made from the Duty Free Shop, City Complex, Karachi on 06.05.2005.
- The Additional Collectors, Deputy Collectors, Assistant Collectors, C.A.O. Auditors and Principal Appraisers shall attend a meeting regarding Budget clarification immediately after announcement of the Budget in the Chamber of Collector (Appraisement).

- 2. TP of LCL Cargo (CFS) including SROs.
- 3. SRO 410(I)/2001 dated 18.05.2001
- 4. SRO 565(I)/2005 dated 06.06.2005
- 5. SRO 576(1)/2005 dated 06.06.2005
- 6. Commercial Afghan Transit
- 7. DTRE & KEPZ
- 2. CSC staff should refer to column No. 30 of GD and particulars of IGM for confirmation FCL / LCL status and Cleating Agent should specifically mention FCL / LCL status in column No. 30 to avoid any complications.
- 3. All the groups should ensure that no GD other than those mentioned in para 1 is processed by them and if SRO claimed by the importer is not applicable, GD should be referred back to import Section for cancellation enabling its subsequent filing in Pakistan Customs Computerized System (PACCS).
- 4. All the above instructions are to be noted by each Groups & CSC officials and to complied with strictly and disciplinary proceedings will be initiated for any deviation.
