Subject: REPAYMENT OF CUSTOMS DUTY ON IMPORT AND ON ACCOUNT OF 15%  
TARIFF PROTECTION IN THE CASE OF PURE TEREPHTHALIC ACID (PTA) -  
PCT HEADING 2917.3610.

In terms of the provisions as contained under Chapter-XX of the Customs Rules, 2001 notified vide SRO No. \_\_\_(I)/2005 dated 13.07.2005, a detailed procedure has been laid down for re-payment of customs duty on import and on account of 15% tariff protection in case of local procurement of Pure Terephthalic Acid (PTA) falling under PCT heading 2917.3610. As per the provisions contained in the aforesaid Rules, the subject refund claims are required to be filed with and to be sanctioned and paid by the Model Customs Collectorate, Karachi.

2. However, keeping in view the fact that presently requisite software arrangements for due processing, sanction and payment of the admissible refund amount by the Model Customs Collectorate is likely to take some time, therefore, it has been decided that till the completion / finalization of the aforesaid software / system arrangements, all such refunds claims on account of PTA shall be filed with the Collectorate of Customs (Appraisement) and shall accordingly be paid by the said Collectorate in line with the procedure as detailed in Chapter-XX.

3. The refund claim shall be filed alongwith all the requisite documents complete in all respect in the Appraising Group-II of the Collectorate. The refund claim so received shall be processed by the Group-II for verification and processing as per the procedure laid down under the rules and all due and admissible claims shall be sanctioned subject to fulfillment of the conditions as prescribed under the relevant rules.

4. This issues with the approval of the Central Board of Revenue.
