CLASSIFICATION OF CERAMIC ROLLERS LHB-75 OF SIZES 42/32 X 3000 MM AND 45/35 X 3110 MM

An issue was forwarded to the Classification Committee for determination of correct PCT heading of ceramic rollers imported by M/s. Karam Ceramic Limited, Karachi. Meeting of the classification committee was held on 10.07.2006 which was attended by the following members and representative of the importer:

- 2. The imported goods were ceramic rollers LHB-75 of size  $42 \times 32 \times 3000$  mm &  $45 \times 35 \times 2930$  mm. The literature described the goods as refractory ceramic rollers containing more than 75% of Alumina (AL2O3). They are used for transportation of ceramic tiles from one place to another place in the kiln during the manufacturing process.
- 3. The referring Group claimed classification of the goods under subhead 9090 whereas the importers claimed classification under sub-head 2000 of heading 69.03.
- 4. The literature furnished by the importers revealed that the ceramic rollers Art No. LHB 75 have the following composition:

PCT heading 69.03 has been sub-divided as under:

- 5. The sub-heading 1000 of heading 69.03 covers only those refractory ceramic goods which contained by weight more than 50% graphite or other carbon or of a mixture of these products. Since the impugned goods neither contain graphite nor contain other carbon, the goods fall out-side the ambit of sub-heading 1000 of heading 69.03.
- 6. The refractory ceramic goods containing by weight more than 50% of alumina (AL2O3) or with a mixture or compound of alumina (AL2O3) and of Silica (SiO2) falls for classification under sub-head 2000 of heading 69.03 since the imported refractory ceramic rollers are comprised of 74 76% alumina (AL2O3) these fall for classification under sub-head 2000 of heading 69.03 by virtue of General Interpretation Rule No.1 of Pakistan Customs Tariff. As such they are not classifiable under sub-head 9000 of heading 6903 or under its further sub-divided headings.
- 7. In view of the above the Committee ruled that refractory rollers Art No. LHB-75 are correctly classifiable under heading 6903.2000 of Pakistan Customs Tariff.
