Determination of Customs Values of Gas Hobs, Stoves, Cooking Range and Parts thereof Under Section 25-A of the Customs Act, 1969.

(VALUATION RULING NO. ¹²⁹⁵ /2018)

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969, Customs values of Gas Hobs, Stoves, Cooking Range & Parts thereof are determined as follows:

2. **Background of the valuation issue:** The Customs Values of Gas Hobs, Stoves and Parts thereof were determined vide Valuation Ruling No 618/2013 dated 06-12-2013. The Valuation Ruling being quite old needed to be revised in line with the prices prevailing in the international markets. Therefore, this Directorate General initiated an exercise to determine the customs values of afore-mentioned goods under Section 25-A of the Customs Act, 1969.

3. **Stakeholders' participation in determination of Customs values:** Meetings with stakeholders were held on 22-12-2017 and 16-04-2018. The participants were requested to submit following documents before or during the stakeholders' meetings.

- i) Invoice of Imports made during last three months showing factual value.
- ii) Websites, names and E-mail address of known foreign suppliers / manufacturers of the item in question through which the actual current value could be ascertained.
- iii) Copies of contracts made / LCs opened during the last three months showing the value of items in question.
- iv) Copies of Sales Tax paid invoices issued during last four months (excluding duty and taxes) to substantiate the contentions of the importers.

4. During the meetings, the Importers contended that the custom values determined vide Valuation Ruling No. 618/2013 dated 06-12-2013 are reasonable and requested to maintain these values or decrease them further. However, no body submitted any tangible documents except some import data of lower values in support of their contentions.

5. **Method adopted to determine Customs values:** Valuation methods given in Section 25 of the Customs Act, 1969 were applied sequentially to address the valuation issue at hand. Transaction Value Method under Sub-Section (1) of Section 25 of the Act ibid was found inapplicable because required information under the law was not available. Identical and Similar Goods valuation methods provided in Sub-Sections (5) and (6) of Section 25 of the Customs Act, 1969 provided some reference values but due to wide variations in the declarations the same could not be relied upon exclusively. In the regular sequential order, this office conducted market inquiries in terms of Sub-Section (7) of Section 25 of the Customs




Act, 1969. Consequently, the Customs values of Gas Hobs, Stoves, Cooking Ranges and Parts are determined under Sub-Section (7) of Section 25 of the Customs Act, 1969.

6. **Customs values of Gas Hobs, Stoves Cooking Range and Parts thereof:** Gas Hobs, Stoves Cooking Range and Parts thereof *hereinafter specified* shall be assessed to duty /taxes at the following Customs Values:


7. In cases where declared/ transaction values are higher than the Customs values determined in this Ruling, the assessing officers shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officer shall take into account the differential between air freight and sea freight while applying the Customs values determined in this Ruling.

8. **Validity of this Valuation Ruling:** The values determined vide this Ruling shall be the applicable Customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Sections (1) or (3) of Section 25-A of the Customs Act, 1969.

9. **Revision of the value determined vide this Valuation Ruling:** A revision petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue of this ruling, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.

10. The Collectors of Customs may kindly ensure that the values given in the Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed may kindly be brought to the notice of this Directorate General immediately. Customs values determined in the ruling are for the description and specifications as mentioned herein. PCT Codes are mentioned for illustrative purposes so that valuation ruling values are made accessible to the assessing officers. The assessment shall be finalized on the basis of correct classification after fulfilling requisite formalities related to importability or any other certification required thereon. In addition to this, it is further necessary to verify that there is no mis-declaration of any sort or violation of Import Policy Order or Section 15 of the Customs Act, 1969 or any other law in vogue therein.

11. ***This ruling supersedes Valuation Ruling No. 618/2013, dated 06-12-2013.***
