<u>Determination of Customs Value of Self Adhesive Sticker Paper in Sheets,</u> under Section 25-A of the Customs Act, 1969

(VALUATION RULING NO. 1334 / 2018)

No. Reg. Misc/06/2012-III/1382

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969, Customs values of Self Adhesive Sticker Paper, are determined as follows:

2. **Background of the Valuation Issue:** The customs values of Self Adhesive Sticker Paper, were determined under Section 25A of the Customs Act, 1969, vide Valuation Ruling No.568/2013 dated 03-07-2013. An exercise was initiated to determine the customs values in the light of current international market price trend.

3. **Stakeholders' Participation in Determination of Customs Values:** Meetings with stakeholders were held on 31-05-2018, 05-07-2018 and 05-09-2018. The stakeholders were requested to furnish the following documents before or during the course of above said meeting:-

- (a) Invoices of imports during last three months showing factual value.
- (b) Websites, names and E-mail addresses of known foreign manufacturers of the item in question through which the actual current value can be ascertained.
- (c) Copies of Contracts made / LCs opened during the last three months showing the value of item in question.
- (d) Copies of Sales Tax Invoices issued during last four months showing the values of supplies (excluding duty and taxes) to substantiate their contentions.
- 4. During the course of meeting, the importers submitted that self adhesive sticker paper vary due to brand, origin and specification however, despite lapse of considerable time, they did not submit any evidences in support of their contentions. During the course of meeting, some importers highlighted that some unscrupulous importers declare less weight of reems of sticker paper, the weight of self adhesive paper is calculated as a packet equals 100 sheets weighing 6.2 -6.4 kg and five packets comprise in one reem (500 sheets (31-32 kg)
- 5. Method Adopted to Determine Customs Values: Valuation methods given in Section 25 of the Customs Act, 1969 were followed to arrive at customs values of selfadhesive sticker paper. Transaction value method provided in Section 25 (1) was found inapplicable because the requisite in ormation was not available. Identical / similar goods value methods provided in Section 25(5) & (6) were examined for applicability to the valuation issue in the instant case



which provided some reference values of the subject goods but the same could not be exclusively relied on. Thereafter, market enquiries as envisaged under section 25(7) of the Customs Act, 1969, were conducted. The self adhesive sticker paper of some specifications was not readily available in the market; therefore, different markets were surveyed repeatedly. Online values of subject goods were also obtained. All the information so gathered was evaluated and analyzed for the purpose of determination of customs values. Consequently, the Customs values of self adhesive sticker paper have been determined under Section 25(7) of the Customs Act, 1969.

6. Customs Values of Self Adhesive Sticker: Self Adhesive Sticker, hereinafter specified, shall be assessed to duty/taxes at the following Customs Values: -

Note: (1) US\$0.050/kg to be subtracted for assessable value of reels of the above said items.

- (2) The Collectorates may ascertain ream weight of self adhesive sticker paper sheets size 20'X30' ranging 31-32 kg for 500 sheets. Each ream consist of 5 packets and the weight of each packet range between 6.2 to 6.4 /kg for 100 sheets.
- 7. In cases where declared / transaction values are higher than the Customs values determined in this Ruling, the assessing officers shall apply those values in terms of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officer shall take into account air freight while applying the Customs values determined in this Ruling.
- 8. Validity of Valuation Ruling: The values determined vide this Ruling shall be the applicable Customs values for assessment of subject imported goods until and unless it is

rescinded or revised by the competent authority in terms of Sub-Sections (1) or (3) of Section 25-A of the Customs Act, 1969.

- **9.** Revision of the Value Determined vide this Valuation Ruling: A revision petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.
- 10. The Collectors of Customs may kindly ensure that the values given in this Valuation Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed may kindly be brought to the notice of Directorate General immediately. Customs values determined in the ruling are for the description and specification as mentioned in the above table of this Ruling. HS Codes are mentioned for illustrative purpose so that valuation ruling values are made accessible to the assessing officers. The assessment shall be finalized on the basis of correct classification after fulfilling requisite formalities related to importability or any other certification required thereon. In addition to this, it is further necessary to verify that there is no mis-declaration of any sort or violation of Import Policy Order or Section 15 of the Customs Act, 1969 or any other law in vogue therein.

11. This ruling supersedes Valuation Ruling No.568/2013, dated 03.07.2013.
