DETERMINATION OF CUSTOMS VALUE OF MOTORCYCLE PARTS
UNDER SECTION 25A OF THE CUSTOMS ACT, 1969

(VALUATION RULING NO.685/ 2014)

In exercise of the powers conferred under Section 25A of the Customs Act, 1969, the Customs values of Motorcycle Parts are determined as follows: -

- Description of the valuation issue:** Customs values of Motorcycle Parts were determined earlier vide Valuation Ruling No.664/2014 dated 31-03-2014 and Amendment Dated 04.04.2014. Being aggrieved and dissatisfied with the said ruling, M/s All Pakistan Motorcycles Spare Parts Importers & Dealers Association and others filed Revision Petition under Section 25D of the Customs Act, 1969 before the Director General of Customs Valuation. After examining the matter, the Director General of Customs Valuation ordered for revisiting the issue and correcting the values as per unit of measurement as per Pakistan Customs Tariff. Accordingly, the Customs values are determined as under Section 25A of the Customs Act, 1969.
- Method adopted to determine customs values:** Valuation methods given in Section 25 of the Customs Act, 1969 were followed. Transaction value method as provided in Sub-Section (1) of section 25 was found inapplicable because requisite information was not available. Identical / similar goods valuation methods provided in Sub-Sections (5) & (6) of Section 25 ibid could not be followed because of considerable variation in declared values among various import values of subject goods. Consequently, findings of market enquiry under Deductive Value Method in terms of Section 25 (7) of the Customs Act, 1969 were adopted to determine the customs values of Motorcycle Parts read with Fall Back Method under section 25(9) ibid.
- Stakeholders' participation in determination of values:** Earlier meetings were called with the stakeholders on 17-03-2014 and 24-03-2014 while issuing Valuation Ruling No.664/2014 dated 31-03-2014 and its Amendment Dated 04.04.2014. The meetings were attended by representatives of KCCI, All Pakistan Motorcycle Spare Parts Importers and Dealers Association (MSPIDA), Pakistan



Automotive Manufacturers Association (PAMA), Association of Pakistan Motorcycle Assemblers (APMA) and Local Motorcycle Assemblers. Being aggrieved and dissatisfied with the said ruling, M/s All Pakistan Motorcycles Spare Parts Importers & Dealers Association and others filed Revision Petition under Section 25D of the Customs Act, 1969 before the Director General of Customs Valuation. After examining the matter, the Director General of Customs Valuation ordered for revisiting the issue and correcting the values as per unit of measurement as per Pakistan Customs Tariff. Accordingly, the Customs values are determined as under Section 25A of the Customs Act, 1969.

4. **Customs values for Motorcycle Parts :** Motorcycle Parts of China origin *hereinafter specified* shall be assessed to duty / taxes on the customs values given against them in the Table below :-



Note: All other motorcycles parts classifiable under respective headings, not specified above, may be assessed not below assessable value of US \$1.45/kg.

5. In cases where declared/ transaction values are higher than the Customs values determined in this Ruling, the assessing officer shall apply those values in terms of sub-section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officer shall take into account the differential between air freight and sea freight while applying the Customs values determined in this Ruling.
6. **Validity of this Valuation Ruling:** The value determined vide this Ruling shall be the applicable customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Section (1) or (3) of Section 25A of the Customs Act, 1969.
7. **Review of the value determined vide this Valuation Ruling:** A review petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.
8. The Collectors of Customs may kindly ensure that the values given in the Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed with respect to PCT may kindly be brought to the notice of Directorate General immediately.
8. **This Valuation Ruling Supersedes Valuation Ruling No.664/2014, dated 31-03-2014 and Amendment Dated 04.04.2014.**
