## NOTIFICATION (CUSTOMS)

S.R.O. 1151 (I)/2007.- In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to exempt, with effect from the $30^{\text {th }}$ November, 2007, the goods specified in column (3) of the table below, falling under the Headings and sub-headings of the First Schedule to the said Act as specified in column (2) of the said table, to the extent of percentage of exemption as specified in columns (4) and (5) of that table, on the import into Pakistan from the Republic of Mauritius, if made in conformity with the Rules of Origin notified by Ministry of Commerce as agreed under the Preferential Trade Agreement between the Islamic Republic of Pakistan and the Republic of Mauritius, namely:-
