Subject: **Development of Valuation Database; Reference value for Endotracheal Tube (Un-cuffed & Cuffed).**

This Directorate General has initiated an exercise to develop database values for different items wherein it has been observed that declarations are of wide range and do not correctly reflect values of the items as traded in the international market. During the scrutiny of previous clearance data, it has been observed that Endotracheal Tube (Un-cuffed and Cuffed) falling under PCT headings 9018.3960, are being assessed at different values and certain transactions are on very low side.

2. This Directorate General, after carefully examining the clearance data, also conducted market inquiries to verify the authenticity of declarations. Online prices were also obtained to corroborate the findings of the market surveys. This office, therefore, has found that the customs values of Endotracheal Tube (Un-cuffed and Cuffed) are as follows:

S. No.	Description	Origin	Customs Value C&F US\$/Pc
1.	Endotracheal Tube (Un-cuffed)	China	0.18
2.	Endotracheal Tube (Cuffed)	China	0.22

3. These values are, however, for reference/guidance only and final assessment may please be made after considering other factors which have bearing on the customs value.

4. The clearance collectories may like to consider the values given above before finalizing the assessment of the subject items. If further fine-tuning in specifications and ensuing values are required, Collectory may forward a reference along with detailed justifications and worksheets so that requisite adjustments are accordingly issued.

5. In case of any grievances, the importer can file a request to the Directorate General along with substantiating evidence/record for reconsideration/review.
