Subject: Values for Washing Machine Parts; Development of Valuation Database Values

This Directorate General has initiated an exercise to develop database values for different items wherear has been observed that declarations are of wide range and do not correctly reflect values of the items as traded in the international market. During the scrutiny of previous clearance data, it has been observed that Washing Macan Parts falling under PCT heading 8450.9000 are being assessed at different values and certain transactions are on low side.

2. This Directorate General, after carefully examining the clearance data, also conducted market inquiries verify the authenticity of declarations. Online prices were also obtained to corroborate the findings of the market surveys. This office, therefore, has found that the customs values of Washing Machine Parts are as follows:-

- The clearance collectorates may like to consider the values given above before finalizing the assessment the subject items. If further line-tuning in specifications and ensuing values are required, Collectorate may forward reference along with detailed justifications and worksheets so that requisite adjustments are accordingly issued.
- In case of any grievance, the importer can file a request to the Directorate General along with substantials evidences/record for reconsideration/review.
- If the clearance Collectorate or any trader / importer / stakeholder is aggrieved by the Valuation Datas values, or further fine-tuning in specifications, and ensuing values is required, the Collector or the stakeholder the case may be, forward a reference to Director Customs Valuation, along with detailed justifications worksheets, substantiating evidences / record so that requisite adjustments are accordingly considered.
