NOTIFICATION

(Customs, Income Tax, Sales Tax)

S.R.O. 577(I)/2005.-In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and clause (a) of sub-section (2) of section 13 of the Sales Tax Act, 1990, ¹[and] sections 53 and 148 of the Income Tax Ordinance, 2001 (XLIX of 2001) ²[***] and in supersession of its notification No. SRO 932(I)/2004, dated the 20th November, 2004, the Federal Government is pleased to exempt old and used automotive vehicles ³[of Asian makes] meant for transport of persons specified in column (2) of the table below, falling under PCT heading number 87.03 of the First Schedule to the Customs Act, 1969 (IV of 1969) on the imports from so much of the Customs duty, sales tax, withholding ⁴[tax and] ⁵[***] as are in excess of the cumulative amount specified in column (3) thereof.

Depreciation in the duties and taxes @ ¹³[1] per month in payable amount as per cumulative scales mentioned in the table shall be allowed subject to a maximum of 50% ¹⁴[but 60% for cars] as per Customs General of 14 of 2005 dated 6th June 2005. Other old and used vehicles shall be assessed as per normal procedure prescribed under the above-mentioned Customs General Order.

3. This Notification shall take effect from the 6th days of June, 2005.
