## Withdrawal of Valuation Ruling No. 256/2010 dated 31-05-2010 of Fax/Facsimile Machine under PCT 8443.3260

Earlier Customs values of Fax/Facsimile Machines of Japan, Far East, Middle East, and China origins were determined vide Valuation Ruling No. 256/2010 dated May 31, 2010. This Directorate General examined the import data of past clearances of subject item, which revealed that very small quantity had been imported into Pakistan during fiscal year 2018-19 and, therefore, did not have any significant impact on revenue. Therefore, this Directorate General is of the view that the valuation ruling on this item should be rescinded and the Collectorates should assess the said items as per the provision of Section 25 of the Customs Act, 1969.

In view of above, the Valuation Ruling No. 256/2010 dated 31-05-2010 is hereby 2. withdrawn.
