Withdrawal of Valuation Ruling No. 477/2012 dated 19-10-2012 of BANANA under PCT 0803,9000

Earlier Customs values of Bananas of India, Philippines & Sri Lanka origins were determined vide Valuation Ruling No. 477/2012 dated October 19, 2012. This Directorate General examined the import data of past clearances of subject item, which revealed that the same had not been imported into Pakistan during fiscal year 2018-19 and, therefore, did not have any impact on revenue. Therefore, this Directorate General is of the view that the valuation ruling on this item should be rescinded and the Collectorates should assess the said items as per the provision of Section 25 of the Customs Act, 1969, if such goods are imported.

2. In view of above, the Valuation Ruling No. 477/2012 dated 19-10-2012 is hereby withdrawn.
