

- 2. The facts of the case leading to formulation of Contravention Report by the reporting agency and the resultant show cause notice are that M/s. Balochistan Engineering Works Limited, 40-C Block-06, P.E.C.H.S Karachi, claiming to be an industry and manufacturer filed a Goods Declaration bearing machine No. KEPI-HC-6434 dated 01.01.2019 in One Customs System for clearance of a consignment declared to contain Iron & Steel (CRC-Prime), 32 Packages/Coils weighing 298.95 MT through their designated Custom House Agent M/s. Cosmos Trading Development (CHAL 1145) for clearance thereof from M/s. Royal Impex (Pvt.) Ltd, KEPZ under PCT heading 7209.9090 (meant for prime quality goods) chargeable to Customs Duty @ 11% and also claimed the benefit of SRO 655(I)/2006 dated 22.06.2006 entitles the claimant to pay reduced rate of Customs Duty @ 1%. if otherwise admissible. The respondent submitted commercial invoices and packing lists bearing No. 1811-173 and 1811-172 both dated 12.11.2018 showing description of goods Iron & Steel Sheets (CRC) and HS Code 7209.9090 (meant for Prime quality goods) issued by M/s. Euro Steel Co Ltd., Korea, covered under Bills of Lading No. JNBGSIM1811001 dated 18.11.2018 & ARONSEL1811001 dated 16.11.2018 covering weight 598.220 MT and 587.900 MT respectively.
- 3. The said Goods Declaration was processed / assessed provisionally under Section 81 of the Customs Act, 1969 on the basis of declaration while applying the prevailing LME price for valuation purposes. Accordingly, the importer deposited the calculated duty & taxes to the tune of Rs. 5,429,966/- vide Cash No. 834 dated 28.03,2019 @ Customs Duty 1%, Additional Customs Duty @ 2% and Sales Tax @ 17% while claiming exemption from Income Tax valid upto 30.06.2019.
