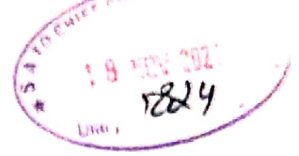

(CUSTOMS)**

S.R.O. (I)/2021.- In exercise of the powers conferred by section 3 of the Customs Act, 1969 (IV of 1969), sections 30 and 31 of the Sales Tax Act, the Federal Board of Revenue is pleased to direct that the following further amendments shall be made in its Notification No.S.R.O.624(1)/2021, dated the 18th May, 2021, namely:-
