REPRESENTATION AGAINST CLASSIFICATION OF SILICONE DEFOAMER UNDER HEADING 3824.9099 DETERMINED BY PCT COMMITTEE VIDE PUBLIC NOTICE NO.06/2016 (A) DATED 3RD OCTOBER, 2016

Please refer to the Office of the Chief Collector, Appraisement-South, Karachi's letter dated 14.10.2022, enclosing therewith a copy of representation dated 12.10.2022 of M/s Dewan Mushtaq Trade limited on the subject noted above.

- 2. Briefly, as per record, M/s Dewan Mushtaq Trade limited filed representation dated 01.11.2016 in Board against subject Public Notice and the Board vide letter dated 25.01.2017 referred the matter to the Collectorate of Customs, Appraisement-East, Karachi for re-examining the same by the Classification Committee. Accordingly, the Collectorate issued a notice of hearing vide letter dated 02.06.2017 for hearing on 08.06.2017 and since then the matter went into oblivion.
- 3. M/s Dewan Mushtaq Trade limited vide representation dated 12.10.2022 drew attention of the Office of the Chief Collector on the subject matter. The Office of the Chief Collector referred the matter to Classification Committee for resolving the same. Meetings of the Classification Committee were held on 24.10.2022, 19.11.2022 and 03.12.2022. The representatives of M/s Dewan Mushtaq Trade limited attended the meeting dated 03.12.2022 and submitted letter dated 03.12.2022 (**Annex-A**), withdrawing their representations dated 01.11.2016 & 12.10.2022. However, during meeting dated 03.12.2022, representatives of M/s Dewan Mushtaq Trade limited contended that some unscrupulous elements are misusing the Green Channel Facility and violating the subject Public Notice.
- 4. In view of the foregoing, the grievances of M/s Dewan Mushtaq Trade limited to the extent of revisiting Public Notice stands addressed/withdrawn.
